
Eileen STANNARD (1906-c. 1986)

Eileen STANNARD, daughter of Thomas Ellis STANNARD (c. 1877-) and Caroline RAYNER (c. 1880-), was born on 15 February 1906 in Diss, Norfolk.^{1,2,3} She was baptised on 23 March 1906 in Diss.³ She appeared in the census in 1911 at Denmark Green in Diss - 5, living with parents Thomas Ellis (34, coal merchant) and Caroline (31), and siblings Thomas Ellis Edmund (8), John Edmund (6), George William (3) and Phyllis (2).⁴ Eileen and **Albert George YOUNGMAN** had marriage banns published on 4 October 1928 in Roydon, Norfolk - bride from Diss; other banns dates were 11/10/1928 and 18.10.1928.⁵ Eileen married Albert George YOUNGMAN on 9 December 1928 in Diss - married after Banns, groom's father a farmer, bride's father a publican.. The marriage was witnessed by Thomas E STANNARD and Caroline STANNARD. The ceremony was conducted by Rev. F. P. Law.^{6,7} Eileen was recorded on the 1939 Register living at 63 Denmark Street in Diss - unpaid domestic duties, b. 15.02.1906.¹ Eileen died circa 1986.⁸

Albert George YOUNGMAN, son of Henry YOUNGMAN (c. 1872-) and Alice GREEN (c. 1869-), was born on 25 April 1902.^{1,9} He appeared in the census in 1911 at Tottington, Roydon, Norfolk in Roydon - 8, living with parents Harry [Henry] (39, farmer) and Alice (42) and siblings Harry (18, fowl dealer), Edith (11), Bertie (6), Leonard (4) and Ivy (under 1 month).¹⁰ Albert was recorded on the 1939 Register living at 63 Denmark Street, Diss Norfolk in Diss - fish merchant, b. 25.04.1902.¹ Albert died on 9 August 1970 in New Maldon, Surrey.¹¹ He was buried on 19 August 1970 in Roydon, the ceremony was conducted by Rev. Charles SIMPSON, curate - cremated in New Maldon, Surrey. Albert had his estate probated on 30 November 1970 in Ipswich, Suffolk - " YOUNGMAN Albert George of 21 Lyndhurst Dv New Malden Sy died 9 August 1970 Probate Ipswich 30 November. £1747."¹²
